The Government of Nepal has received a grant from the Asian Development Bank (ADB) toward the cost of **Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP)**, and it intends to apply part of the proceeds of this grant to payments under the contract for Supply & Delivery of Four Wheel Drive Double Cab Pick-up under International Competitive Bidding Procedures.

The Department of Local Infrastructure Development and Agricultural Roads (DoLIDAR), Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), Project Coordination Unit (PCU) now invites sealed Bids from eligible Bidders for Supply & Delivery of Four Wheel Drive Double Cab Pick-up (24 Nos).
3. International Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One Envelope procedure and is open to all Bidders from eligible source countries.

Interested eligible Bidders may obtain further information from the Department of Local Infrastructure Development and Agricultural Roads (DoLIDAR), Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), Project Coordination Unit (PCU) and inspect the Bidding Document at the address given below during office hours.

The Bidding Document, in the English language, may be purchased by interested Bidders on the submission of a written application to the address below and upon payment of a nonrefundable fee **NRS 5000.00**. The method of payment will be in cash. The document can be purchased by the bidder or his/her representative.
6. Bids must be delivered to the address below at or before 12 hours of 07 August, 2008. All Bids must be accompanied by a Bid Security of **minimum US \$ 26,000.00** or equivalent Nepalese currency . *If the bid security is issued by the banks outside Nepal, the bid security shall be counter guaranteed by Commercial banks within Nepal.* Late bids shall be rejected. Bids will be opened in the presence of the Bidders or their representatives who choose to attend at the address below at 14 hours of 07 August, 2008.

The Department of Local Infrastructure Development and Agricultural Roads (DoLIDAR), Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), Project Coordination Unit (PCU) will not be responsible for any costs or expenses incurred by the Bidders in connection with the preparation or delivery of the Bids.
